The list of advance reservations is posted daily at the main parking lot at MNRA. Sites, *other than Bluestem Campsite & Social Center*, **NOT** reserved are available on first come first served basis at the Macbride Nature Recreation Area by completing this form.

In order that this area may remain available for your outdoor enjoyment, we ask that you adhere to the following rules and regulations:

1. Camp site reservations begin at NOON and end at 11:00 a.m. the next day. Picnic/shelter site reservations begin at opening of the park and end at closing of the park. Picnic/shelter areas **MUST** be vacated when the park closes.
2. All fires must be made in fire rings **ONLY**.
3. Noise must be kept to a minimum so as not to disturb other users. Excessive noise can result in attendees being asked to leave.
4. A clean-up fee (to be determined by condition) will be assessed to any user not leaving the site ready for the next user.
5. All privately owned animals must be on a leash not to exceed 6 feet.
6. Alcohol is **NOT** allowed in the park.
7. Do not set up equipment before checking the site reservation box located at the front of each area. If there is a reservation slip posted, then the site is **RESERVED**. Do not remove slip and replace with another.
8. Only one site can be reserved per person.
9. Cancellations must be made at least 48 hours prior to arrival (50% handling fee will be applied to the transaction).
10. Reservations must be made in person at the Recreational Services Office, E216 Field House, Iowa City, IA
